Hello OOHA Neighbors—

As we discussed at January's AGM, the Board has been taking steps to update and modernize OOHA's governance documents. As a reminder, Colorado law governing HOA's has changed several times since we last updated our documents, and consequently many of our governance policies are no longer in compliance. Additionally, we would like to consider updating some of our other rules, because although they are legal, they could be streamlined to make it easier to run the neighborhood.

Since January, the Board has retained a law firm and received an analysis of our current documents (posted here if you would like to dive deeper). The next step is to revise these documents so they can be presented to the entire neighborhood for approval, ideally timed to coincide with next January's annual meeting. Because our rules dictate that a relatively high number of households must approve these changes in writing, we would like to make the changes in one shot, rather than doing it piecemeal.

To that end, the Board has voted to form a small governance documents working committee, which will work with the outside lawyer to draft revised documents. We'd like to solicit one to three volunteers who are not currently on the Board to sit on this committee, along with a small number of current Board members.
